Roll Call

Members present: Secretary Mannix; Members Gustafson, McCluskey, Sheehan-Smith, and Williams. Chairperson Pagni, Vice Chair McVey, and Member Segerstrom were absent. Leigh Shampain, SES Superintendent of Schools was also present.

Motion to Approve Agenda – Action: Discussion Item 00-03 was amended, "COC Members (2013) may now serve an additional <u>two-year term</u>." The amended agenda was approved on a motion by McCluskey seconded by Sheehan-Smith. Ayes (5) Gustafson, Mannix, McCluskey, Sheehan-Smith, and Williams.

00-01 Consent Agenda (Single Motion Needed)

00-01.1 **Approval of Minutes** of COC Meeting September 5, 2012

Motion to Approve Consent Agenda – Action: Carried on motion by Sheehan-Smith seconded by Williams. Ayes (5) Gustafson, Mannix, McCluskey, Sheehan-Smith, and Williams.

Discussion Items

00-02 SES Plans to name a Taxpayers' Association Representative

Superintendent Shampain told COC members of actions underway to find a Taxpayers' Association Representative. Member McCluskey said the SSS has a page on Facebook that could be used to share that information more widely. The Superintendent said he would email information to Member McCluskey for use on Facebook.

00-03 COC Members (2013) may now serve an additional two-year term.

Recent legislation enacted into law in Sacramento has extended the maximum term for COC members from two two-year terms to three two-year terms. Six

current COC members COC have initial two-year term appointments expire in March 2013. Members McCluskey and Williams's terms expire in 2014. Members Gustafson and Mannix told the Superintendent that they would be willing to accept another two-year appointment if the SES Board was so inclined.

The Superintendent asked the other four COC members whose terms expire in 2013 (McVey, Pagni, Segerstrom, and Sheehan-Smith) to please let him know whether they are willing to serve another two-year term starting in March 2013.

00-04 Possible COC Outreach Cable TV, Union Democrat

Superintendent Shampain reported that County Superintendent of Schools had contacted him and offered time on Channel 8 Cable TV for a discussion of the Bond Issue and the work of the COC. Unfortunately, the time slot offered was next week; too soon to put together a group and a set of topics. There was agreement that a program on Cable 8 was a good idea and should be prepared. The County Superintendent will have another time slot available that would give the School Board, the District Administration, and the COC time to be ready.

The COC consensus was that our Chairperson should participate in the program together with Superintendent Shampain, one or two SES Board members and someone from the School District staff. Member Sheehan-Smith said she would be happy to help with preparations for the program. Superintendent Shampain said the tape of the program would be useful to the School District.

00-05 Bond Accounts paid as of 10/11/12

Much of the meeting involved a discussion of the "Bond Accounts Payable Paid – Listed by Vendor, Current Amount Paid as of 10/11/2012" that the Superintendent sent to the COC earlier this fall. The COC Secretary raised questions or comments he had received from COC members after they reviewed the document. At the suggestion of Members Sheehan-Smith and Williams, the Secretary has attached to these minutes a compilation of the items discussed. The Superintendent will respond to the items mentioned.

During discussion of the Bond Accounts document, the Superintendent reported that the Bond Audit for July 1, 2011 through June 30, 2012 will be presented to the SES School Board at its March 13, 2013 meeting. He said he would give the COC a copy to review as soon as he could.
